

## Advisory for Indian Nationals in Japan – COVID 19

**No scheduled international commercial passenger services shall be permitted to land at any airport in India till 1830 hrs GMT of April 14, 2020 (0330 hrs Japan Standard Time / 0000 hrs India Standard Time of April 15, 2020).**

In view of these travel restrictions, all Indian nationals in Japan are advised to:
